**INVITATION TO BID FOR THE PROCUREMENT OF  
SECURITY SERVICES FOR THE EMBASSY OF THE  
PHILIPPINES IN BANGKOK FOR CY 2021**

1. The Embassy of the Philippines in Bangkok, Thailand, through the applicable authorized appropriations under the General Appropriations Act of 2021 and Job Request No. 2020-11-30 dated 27 November 2020, intends to apply the sum of One Million Five Hundred Sixty Thousand Thai Baht (THB 1,560,000.00), or Forty-Five Thousand Eight Hundred Eighty-Three US Dollars (USD 45,883.00), or Two Million Four Hundred Thirty-One Thousand Seven Hundred Sixty-Four Pesos and Fifty-Five Centavos (PHP 2,431,764.55), being the Approved Budget for the Contract (ABC) to payments under the contract for the “Procurement of Security Services for the Embassy of the Philippines in Bangkok for CY 2021”. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Embassy of the Philippines in Bangkok, Thailand - Bids and Awards Committee (BAC) now invites bids for the above Procurement Project. The contract is expected to start on 01 January 2021. Bidders should have completed, from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
4. Prospective Bidders may obtain further information from the Embassy of the Philippines and inspect the Bidding Documents at the address given below during office hours, from 9:00 a.m. to 5:00 p.m.
5. A complete set of the Bidding Documents may be acquired by interested Bidders from 08 to 29 December 2020 from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of THB3,208.00 (USD95.00 or PHP5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees by providing a copy to the Procuring Entity or through sending it to the given email address below.

6. The Embassy of the Philippines in Bangkok, Thailand - Bids and Awards Committee (BAC) will hold a Pre-Bid Conference on 15 December 2020 at the Embassy of the Philippines, 760 Sukhumvit Road corner Soi Philippines (30/1), Khlong Tan, Khlong Toei, Bangkok, Thailand 10110 which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below; (ii) online or electronic submission as indicated below; or (iii) both on or before 29 December 2020, 17:00h. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on 29 December 2020 at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. For large files uploaded for online bid submissions, bidders may also consider storing the data in a flash drive to serve as a back-up data of the bid.
11. The Embassy of the Philippines in Bangkok, Thailand - Bids and Awards Committee (BAC) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
