TECHNICAL SPECIFICATIONS

Embassy and Consular Buildings Repair and Maintenance Project

Background	The Philippine Embassy intends to avail of the services of a reputable Thai company based in Bangkok to work on the Embassy and Consular Buildings Repair and Maintenance Project.
Scope of Work	The Contractor shall undertake the following services:
	 A. Repainting of the exterior walls of the Embassy building 1. Remove the old paint. 2. Repair cracks on the walls. 3. Apply old plaster primer work. 4. Repaint the walls.
	 B. Repainting of the interior of the main building of the Embassy which will cover the corridors, walls, ceilings, stairs, including the lining board on the first and second floors. 1. Remove the old paint. 2. Repair cracks on the walls and ceilings. 3. Apply old plaster primer work. 4. Repaint the walls, ceilings, stairs and lining board
	 C. Repainting of the toilets on the first and second floors of the main building of the Embassy. 1. Remove the old paint. 2. Repair cracks on the walls and ceilings. 3. Apply old plaster primer work. 4. Repaint the walls, ceilings and doors.
	 D. Repainting of the interior of the annex building of the Embassy (Consular and Attached Agencies) which will cover the corridors, walls, ceilings, toilets, and damaged doors on the first and second floors of the annex building. 1. Remove the old paint. 2. Repair the cracks on the walls and ceilings. 3. Repair the damaged walls and ceilings with molds. 4. Remove the molds. 5. Apply anti-moisture treatment on the walls and ceilings as appropriate. 6. Apply old plaster primer work. 7. Repaint the concerned areas.

	J. Any other repairs of the building that need urgent attention as mutually agreed by both parties and within the allotted ABC.
Work schedule	The schedule of repair, repainting, and all activities concerning the project shall be mutually agreed upon by the Embassy and the Contractor with the objective of not interrupting the operations of the Embassy and the Consular Offices. Services beyond office hours, weekends, and holidays may be done if needed.
Terms of Payment	Full payment shall be made within seven (7) days from the receipt of the official invoice. The quote should be exclusive of VAT.
Other Conditions	The Contractor shall provide professional workers, equipment and other tools required for the project. Workers must strictly follow all COVID 19-related health and safety protocols set by the Embassy in compliance with the COVID 19-related health measures and regulations of the Royal Thai Government.
